**Movement Lawyering:** Under this priority, we seek to support organizations that are working at the intersection of law and community organizing. Strong applicants will have existing ties with community organizing groups, a base of community members, grassroots campaigns, etc. The result of ChangeLawyers funding in this area will be a stronger eco-system for movement attorneys who advocate for and win more equitable laws, policies, and outcomes for their communities and clients. Organizations can apply for a maximum grant amount of \$40,000 for one year.

Capacity Building: Under this priority area, we seek to support legal organizations committed to building a better justice system-one that works for all Californians. Organizations applying for funding in this priority area must have less than a \$1 million dollar budget, and should be able to showcase how they are ready to take the next step in growing their organization's work in supporting our most vulnerable communities. Organizations can apply for a maximum amount of \$40,000 for one year.

**Leadership:** Under this priority area, we seek to support organizations that are training changemakers to rise to positions of power and influence within the legal landscape. Examples include but are not limited to organizations working to: build young leaders (in law school or early career attorneys) and/or upskill established attorneys so they can reach their leadership potential and enhance their impact. It is imperative that organizations be able to track and showcase the impact of their support/training in rising to positions of power within law. Organizations can apply for a maximum amount of \$40,000 for one year.

**Next Gen Fellowship:** Under this priority area, we seek to support legal organizations with a clear mentorship/supervision model that will strengthen a legal fellow's knoweldge of the law and build their professional skills. Priority will be given to organizations that have a legal project the fellow can immediately begin work on. Organization will receive a grant in the amount of \$80,000 for one year. \*Due to the larger grant amount, this priority area will be the **most competitive**.
